Dear Member -

By the time you receive this issue all those clearly eligible for benefits under the new legislation will have received their moneys and details of their new payments. Despite the taxman the net results should be very helpful and it makes the 41 months we have been pursuing the benefits all seem worthwhile.

However your Committee is still worried about two groups. The first is that small band of Papuan Fund widows whose husbands in the early years were not able to join a superannuation fund simply because there was at that time no such thing. Instead they took out insurance and when finally a superannuation fund was established they were already "locked in" to their insurance payments and could not afford to pay superannuation as well on the salaries then paid. Their widows were left with the small insurance lump sum and no superannuation pension. I have already made initial inquiries on their behalf and it seems that ex gratia payments by the Minister may be the only method of helping them. Your Committee will be following up this matter but we need some more information. We do have some Papua Fund widows on our books but there may be others and we need to have accurate numbers. Would all Papua Fund members and widows therefore please write to the Secretary (P.O. Box 199, Mosman, 2088) giving (a) name and address, and (b) present financial position, and (c) whether you wish us to act on your behalf. Such information will be confidential to myself and the small sub-committee looking after this matter. Would you also ask Papua Fund widows who are not Members to also contact me.

The second group are those widows, wives or de facto wives who may not be eligible for benefits, including widows who may have remarried. The regulations covering this group are rather complicated and as a generalisation each case would need to be treated individually. The Commissioner has a discretionary power; for example, where the widow remarried before 1 July 1979, a previously cancelled pension may be restored where the widow is in necessitous circumstances, or the restoration is otherwise warranted, having regard to her general financial circumstances.

The Commissioner has written to all those whom he believes are entitled to new benefits, but there are some for whom he does not have current addresses, or he may not even know of other people who may now be eligible. Members are therefore urged to give the good news to any widow who has remarried, or any widow who married her husband after he had retired from P.N.G. People who believe they are now entitled to new benefits but are not receiving them should write for further information to the Commissioner for Superannuation, Australian Government Retirement Benefits Office, Papua New Guinea Superannuation Schemes, P.O. Box 22 Belconnen, A.C.T. - Attention Mrs. J. Falconer. Members are also welcome to seek advice from this Association, which has legal expertise available.
