The Consumer Price Index rose by 2.3% for the December quarter. In our next issue, after the end of the March quarter, we can give a good estimate of the percentage increase on our superannuation we can expect but on present indications it will probably be about 81/2%.

Your thoughts about this idea and if you agree, your suggestions are sought as to what kind of function and where. These could be given verbally at the A.G.M. or in writing.

We have recently received the Annual Reports of the Commissioner for Superannuation to the Minister for Finance in respect to PNG for both 1982 and 1983. The 1983 Report is printed below:

#### PAPUA NEW GUINEA SUPERANNUATION SCHEME

#### The Scheme

- 1. Since 1 July 1976 the Papua New Guinea Superannuation Scheme has been administered by the Commissioner for Superannuation in accordance with section 20 of the Papua New Guinea (Staffing Assistance) Act 1973. Any contributions received are paid into, and all benefits are paid from, the Consolidated Revenue Fund.
- 2. The detailed provisions of the Scheme are contained in the Papua New Guinea (Staffing Assistance) (Superannuation) Regulations made under section 65 of the (Staffing Assistance) Act. There were no amendments to the Regulations during the year.

#### Contributions

3. Contributions received during the year amounted to \$9124. This comprised payments from those members, retired on or before 30 June 1978 and before attaining maximum retiring age, who elected to purchase a full pension and pay outstanding contributions by way of fortnightly deductions from pension.

#### Pensions

4. During the year 23 new pensions were approved and 27 were terminated reducing the total number of pensions being paid at 30 June 1983 to 676. Details of the pensions are shown in the following Table.

- 5. Of the 27 pensions that ceased to be paid during the year, 22 were terminated on account of death and 5 due to cessation of children's pensions.
- 6. Total expenditure on pensions during the year was \$10 052 116. The annual liability for the 676 pensions being paid at 30 June 1983, including the increasas that became payable on the first pension payday in July 1983, was \$11 122 200.
- 7. There was no change during the year in the number of invalidity pensions suspended on account of employment, the number remaining at 4. The annual value of these pansions if not suspended would be \$61,175.

Naw Guinea Superannuation and Fapua Superannuation.

- 8. The Commissioner for Superannuation also administers the payment of pensions approved under the Superannuation Ordinance 1928 of the Territory of New Guinaa and the Superannuation Ordinanca 1917 of the Territory of Papua. The Funds astablished for the purposes of these Ordinances have not existed for many years and the full cost of the pensions is met by the Commonwealth.
- 9. Pension payments made during the year for New Guinea pensions and Papua pensions totalled \$462,617 and \$113,363 respectively.
- 10. At 30 June 1983 there were 15 malas and 47 widows receiving pensions arising from the New Guinaa Ordinance, this baing 6 less malas and 3 more widows than at 30 June 1982. The annual liability, including pansion increases payable in July 1983, was \$510,857. There were 11 males recaiving pensions arising from the Papua Ordinance, which did not provide for either widows' or childran's benefits, (annual liability \$126,286), this being the same number as at 30 June 1982.

#### CONTRACT OFFICERS RETIREMENT BENEFITS SCHEME.

Lump Sum Payments

11. All former officers' entitlements have now been finalised and the Scheme is effectively closed.

#### MISCELLANEOUS

#### Ombudsman Enquiries

12. There were no enquiries relating to Papua/New Guinea superannuation matters received from the Ombudsman during 1982-83.

#### Reconsideration of Decisions

13. No raquasts for reconsideration by the Commissioner for Suparannuation of decisions taken under the superannuation and ratirement benefits provisions of the Fapua New Guinea (Staffing Assistance) Act 1973 or the Regulations were racaived during the year.

#### Representations by Membars of Farliament

14. Another avenue of external review available to former members of the Schema is by representations to the Minister for Finance or the Commissioner through a Member of Farliament. Six such approaches were made during 1982-83.

#### Freedom of Information

15. No requests under the Freedom of Information Act 1982 were received during the year for access to documents relating to the various Papua/New Guinea Schemes.

We have been in touch with the Commissioner's office about the Medicare Levy and I believe you will all have received a letter to inform you that it is being deducted as from 1st February 1984 at the rate of 1% for a full year or 0.416% (5/12 of 1%) until 30th of June this year.

The Office assured us that superannuants living overseas will not have the Medicare levy deducted but it would be wise for anyone who does live out of Australia to check that there has been no variation in their superannuation payments and write immediately to the Commissioner if there has been. It is possible that some Members may have an Australian address but actually live overseas, and if this is the case such Members should write immediately to the Commissioner, or if they can obtain one, send a completed Medicare Levy Variation Declaration to his Office.

"TAIM BELONG MASTA" The Australian involvement with Papua New Guinea.
by Hank Nelson, Published by the Australian Broadcasting Commission.
1982.

Many Members will have heard the programme of this title broadcast by the A.B.C. in 1981. The radio programme, a series of broadcasts, was based on interviews made with many former PNG residents.

Both those who heard this interesting programme and those who missed it will welcome the publication of this book, based on the radio talks. In twenty-four chapters the book deals with the subjects covered in the radio programmes from first contact with a new land and with newly contacted people to Independence and "going finish".

As Hank Nelson states in the introduction: "The aim of the radio series Taim Belong Masta was to persuade many different Australians to talk about themselves in Papua New Guinea. We wanted them to say why they went, what they did and what they took away.... They cover an apparent telescoping of massive change." This was achieved.

The great value of the broadcasts was that former territorians were allowed to describe their experiences and views — we could hear and recognize their voices. This personal touch is retained by the book — one can sense that it is more an account by the people who lived and worked in PNG than just a story by someone who went there just to collect material for a book. Many Members, even those who did not participate in the programme, will be able to identify themselves with the book and with the comments made by their former fellow officers.

The book is published with a soft cover and is well illustrated with black & white photographs, particularly from the pre-war period of Papua and New Guinea.

Pope John Paul will visit Papua New Guinea from 7th to 10th May this year. The Pope's visit will not be his first, as he visited friends in Goroka in 1973.

The Anglican Church of PNG has elected Bishop George Ambo from the Northern Province as Archbishop. He has been a senior Bishop since the retirement of Bishop David Hand in May. Bishop Ambo is married with 3 daughters and 3 sons.

A plan for a Mall in Lae city has been completed and will be ready for construction soon. Second and Fourth Streets, Coronation Drive and Central Avenue will be closed. An artificial lake, an amphitheatre, a stage, a fountain and an artifact market will be constructed.

From January 1st employees will be taxed on the value of their whole income, rather than just their wages. Included will be tax on accommodation, motor vehicles, domestic servants, public utilities and electricity provided as part of the employees work permit.

The city of Lae and the Australian city of Cairns have become sister cities. The Mayor of Cairns said that he was delighted with the link. He said that both cities had much in common, topography, location, commerce and population numbers.

Clem Rich was the second son of the well-known L.M.S. family. Born in 1905 at Kwato, he joined the Papuan service in 1924. He soon became an A.R.M., serving in most areas of Papua. He enlisted in the army in Australia but returned to Papua as O.I.C. A.N.G.A.U. on the Bulldog Road. Post war, Clem served in the Milne Bay area and retired in 1951. He spent most of the rest of his life in the Ferguson Islands, where he passed away.

Alan Roberts, originally a teacher in Victoria, was one of the first six + cadet patrol officers appointed to New Guinea in 1925. His early service + was in Aitape and Morobe and he was ADO Kokopo when the Japanese came, + escaping to Australia with a RAAF party. Returning to PNG he became a major + in ANGAU, serving at Jacquinot Bay and then H.Q. at Moresby. + Post-war, after a period in Lae as A.D.O then D.O Morobe, Alan went to

Moresby as Assistant Director in 1949, and in 1953 took over from J.H. Jones as Director of District Services & Native Affairs. He retired to Heidleberg in 1966 where he resumed drawing and painting, at which he excelled. He died at 79 years of age.
