the quarter ended 30 September 1984 the C.P.I. rose by 1.4%. I am not in the business of 'guesstimating' what the overall annual change will be by the 31st March 1985, which will decide what percentage rise in superannuation we may expect in July, but I think we would be foolish to bank on anything more than 6% increase.

The Commissioner for Superannuation and his staff sometimes get blamed for delays which are really our own fault -- or the fault of our representatives such as trustees or solicitors. For example, when a superannuant dies his spouse, trustee or solicitor fails to send to A.G.R.B.O. Canberra one or more of the necessary certificates. We strongly advise all new widows to adopt the following procedure:

1. Advise the Commissioner for Superannuation, P.N.G. Section, P.O. Box 22 Belconnen, A.C.T. 2601 of the death of the superannuant as soon as possible, at the same time formally apply for the spouse's pension and ask for the form "Application for Spouse's Benefit on Death of a Pensioner" to be sent to you.
2. When received, complete this form and return it to the Commissioner together with a photocopy of your marriage certificate and a photocopy of death certificate.

Do not delay returning the completed form because the death certificate is not yet available - instead enclose a copy of the death or funeral notice from the newspaper, making sure the name of the newspaper and the date of the entry is marked on it. Then forward a photocopy of the death certificate when you receive it.

Failure to notify the Commissioner quickly may mean that your husband's pension may continue, so that overpayment occurs and you will have all the hassle of returning the money. So -- to help yourself make sure that you or your solicitor or trustee act as above.

THE ANNUAL REPORT FOR 1983-84 FOR PAPUA NEW GUINEA SUPERANNUATION SCHEME

The main points of the Report are summarized below:

The Commissioner for Superannuation is responsible for the payment of pensions under the Superannuation Ordinances of the Territory of Papua 1917, the Territory of New Guinea 1928, and the Papua New Guinea Scheme 1973. The few contributions are paid into, and all benefits paid from, the Consolidated Revenue Fund:

Total expenditure on pensions during the year amounted to \$10,974,860. The annual liability for the year ending 30 June 1985 in respect of the 666 pensions in force at 1/7/84 is \$11,489,901; this includes the pension increases that became payable on the first pension payday in July 1984.

PAPUA SUPERANNUATION AND NEW GUINEA SUPERANNUATION SCHEMES

Ten males were receiving pensions under the Papua scheme at 30/6/84, one less than previous year. The Scheme did not provide benefits for widows or children. Expenditure on pensions for the year amounted to \$121,559. 15 males and 48 widows (up 1) received pensions under the New Guinea scheme at 30/6/84. Expenditure was \$501,672.

MISCELLANEOUS

The administrative costs of the Australian Govt Retirement Benefits Office are met from an annual appropriation from Consolidated Revenue. Cost of the administration of the PNG Superannuation Scheme and the other schemes included in the Report was estimated to be \$80,000 for the year ended 30 June 1984.

There were no enquiries relating to Papua/New Guinea superannuation matters received from the Ombudsman during 1983-84.
