#### CPI ADJUSTMENT TO SUPERANNUATION

As will be seen from the above, the increase in the Consumer Price Index for the twelve months from 1 April 1991 to 31 March 1992 was 1.7%. This means that superannuation pensions should increase by that percentage from the first payday in July, i.e. 9 July 1992.

The Office of the Commissioner for Superannuation will endeavour to forward Group Certificates with their notification concerning the pension increase. But, as they are dependent upon another government department to enable them to do this, it is not always possible. Group Certificates will be posted to those concerned as soon as the Office receives them, so please do not pester the Office staff if you do not receive your Group Certificate with your notice re pension increase. Be patient, it has not been overlooked and will arrive in due course, which could very well be some two or three weeks later.

I was surprised to hear that Bert Weston was 91 years young. I remember him when I was working for Holden Air Transport Services in Salamaua. He lived on one side of the aerodrome and I lived on the other."

# NEWS FROM CORRESPONDENTS

#### DOUG FRANKLIN (Brisbane)

Andree Millar recently celebrated her 79th birthday at a party given by Heather and Syd Saville at their Burpengary Queensland home. Russ and Meryl Stephenson ex UPNG, Pam and John Brooks, John Wicks ex Adcol, Jack and Bette Pini ex Comworks, Frank and Mrs Waite and Pam and Doug Franklin sang Happy Birthday. Andree responded with her usual gusto, enjoying every minute.

Doug said going on the special 15 day cruise on the Russian ship Belorussiya from Sydney was like winning a lottery jackpot. The cost for a two berth en suite cabin was little more that the return economy air fare from

Brisbane to Moresby.

The cruise which coincided with the 50th anniversary of the Coral Sea Battle in 1942 was both splendid and moving. Anzac Day at sea started with a Dawn Service. The ship slowed, turned due West as the first rays of light came over the Eastern horizon. We assembled on the stern. Then the Last Post, Minutes Silence disturbed only by the sound of the sea, and Reveille, followed by three long blasts on the ship's siren and wreaths into the sea. Off Honiara, at 1100 hrs we circled directly over HMAS Canberra, lying 730 metres below us on the bottom. 85 RAN men lost their lives on that ship in 1942. Jack Anstey, one of the survivors, who lives near Ballina, had the sad duty to cast a wreath in memory of his mates.

But there was a brighter side to the daily routine on board which was

meeting and getting to know many distinguished old coasters.

<u>Jack Goad</u> - ex Collector of Customs Rabaul and Lae. He was in Kieta in 1926 as a boy. During the war he joined the N.G.Volunteer Rifles. When the country was occupied by Japanese he became a Coast Watcher. Eventually he and some others escaped to Cairns in a small coastal vessel. After the war he was appointed to the War Damage Commission. Jack had a total of 49 years in PNG. He is very well and lives near Brisbane. He was lucky at Bingo and won \$500 during the cruise in a jackpot.

John Goad - also Customs and his sister Ellen travelled with their Dad

on the cruise.

Ian Wood was one of the originals in DASF. He went to PNG in 1935 as a Cadet Patrol Officer, posted to Lorengau. The then Director of Agriculture George Murray found out that Ian was a Gatton College graduate (1933), and convinced him to change from DDA to DASF. Clive Green was his OIC, who subsequently lost his life while being sent to Japan as POW on a ship that was sunk. Ian had postings to Keravat and Aiyura in 1937. In 1938 he was posted to Wewak as the first Agricultural Officer with responsibility for the coast up to the Dutch border and up the Sepik as far as Ambunti. At that time there was a gold rush on the Screw River near Maprik. He said that there were over 100 expat miners at one time including Jack Thurston and Mick Dwyer.

A great potential was recognised for the Maprik area, especially for Cocoa and Upland Rice. Ian surveyed and mapped out the Bainyik Agricultural Station. In 1941 he returned to Australia and trained as a Catalina pilot in the RAAF. With his expert local knowledge he was posted back to New Guinea with the RAAF and involved with landing MOSS (Special Service troops) behind enemy lines. On one of the incursions he landed Nip Blood, an ANGAU Police Officer on the Chambri Lakes. Later, Nip was ambushed by the Japs and captured. He escaped and trekked his way to the Highlands, no mean feat, and reached Wabag. He radioed his position, Ian immediately flew to Wabag in his Catalina and dropped food, blankets and essential supplies including a bottle of rum disguised inside a loaf of bread, which landed safely. Nip sent a pradio thanking Ian for the nectar!

The President welcomed members and their guests, especially those from the country and interstate, also members attending for the first time.

The Minutes of the AGM of April 1991 having been circulated in 'Una Voce' were confirmed on the motion proposed by Mr Keleny, seconded by Mr Williams. Carried.

The President read a letter received from the Consul-General, Mr William Nindim, which conveyed his good wishes to the Association and stated "If there is anything we in Sydney can do to either assist your members in any way or to foster the aims and objectives of your Association, we would be most pleased to do so." He also said that he felt "that goodwill among Australians for Papua New Guinea is real and growing all the time."

Mr. Parrish presented his Report:

"I place on record the excellent relationship we have again enjoyed with

the PNG Consul General in Sydney, Mr. William Nindim and his staff.

The staff of the Commissioner for Superannuation in Canberra and in particular Ms. Karen Lenton, who took over early last year from Mrs. Shirley Baldwin, have continued to be most helpful with respect to any queries or problems experienced by member superannuants which have been referred to us. If there are delays attending to super matters I am sure that it is not due to lack of action by the Commissioner's staff, as many matters have to be referred to other Departments, such as Finance or Treasury, and the wheels of the bureaucracy continue to turn very slowly.

Mr. Colin Smith has retired as Secretary of the NSW Branch of SCOA(Superannuated Commonwealth Officers' Association) and, although he was our main contact with that organisation, our Deputy President, Mr. Fred Kaad, has forged new contacts with that organisation. Fred continues to pursue the question of payment of full pension to the surviving spouse for a period after the death of a superannuant but, as reported in the last issue of the

Newsletter, so far without success.

It is again my pleasure to report that during the past year I have continued to have the support of a most co-operative, willing and helpful Committee which, as I reported last year, has changed little during my term of office. We were, however, very saddened late last year by the death of our youngest member, Mr. Tony Pitt.

Mr. Jo Nitsche and Mrs. Pamela Foley, as Secretary and Assistant Secretary respectively, have between them continued to carry out the secretarial and administrative functions of our organisation in a most

exemplary manner.

Mrs. Elma Holmes, in her first year as Treasurer, has performed her duties most efficiently and, with the assistance of some other members of the Committee, has worked hard to complete the installation of a completely new set of financial records.

Our Honorary Auditor, Mr. Len Bailey, in addition to continuing to audit our books of account in a most competent manner, has helped with advice concerning the establishment of our new financial records and the preparation and presentation of our Financial Statement and Balance Sheet. I place on record our appreciation of his efforts and thank him for running off copies

of the documents you have received to-day.

Mr. Bob Pulsford has again assisted me with the Newsletter by proof reading, condensing articles when necessary and undertaking Book Reviews. Mrs. Pamela Foley again did most of the typing in draft form for the Newsletter, was most helpful generally in its preparation, maintaining and updating our Membership List, producing the mailing labels and with Mrs. Pat Jones preparing the mailing wrappers. All the Committee assist with the wrapping of the Newsletter which is wrapped and posted in the one day. Mrs. Linda Evans, Messrs. Les Williams and Dave Marsh also assist with this latter task.

Harry West, although again Chairperson of our Social Sub-Committee, was not able to devote as much time to this task as previously due to very pressing and urgent family responsibilities, continued to be ably supported by Jo Nitsche, Pamela Foley, Pat Hopper and Tony Pitt, who all did a great job in organising our functions. Our last Christmas Luncheon was the best ever

with 194 members and guests in attendance, a great effort.

Mrs. Pat Hopper, Chairperson of our Caring Sub-Committee, with Mrs. Pat Jones, Mrs. Roma Bates and Mr. Frank Smith continued to do an excellent job of contacting members whom they know have been ill, visiting those they have been advised are in hospital and sending greetings etc. to our more senior members to let them know we still think of them.

We have again been most fortunate and honoured in having Sir Horace Niall and Mr. Bill Seale as our Patrons and we very much regret that Bill's

health is such that he has been unable to be with us.

Many thanks again to those members who provide me with articles and the information which enables me to produce the Newsletter, in particular our correspondents in the various States and the Northern Territory, Mr. Jim Toner in the latter, Mr. Doug Franklin, Mr. Geoff Masters and Mrs. Isobel Pert in Queensland and Mrs. Margaret Clancy in Western Australia. There is still a great number of members with interesting stories to tell and I sincerely wish that they would put pen to paper with contributions for the Newsletter, particularly as Old Father Time is catching up with many of us.

The Association, over the past two or three years, has to a large extent become the archive for information concerning personnel who served in PNG, not only in the Public Service but also in Private Enterprise, the Missions, in Research and other capacities. To assist in this development we asked members during the year to help us update our membership records and received a good response to this request with 305 members completing and returning the 'Update

Forms'. This means, however, that we still have very little information about over 400 of our members, so the Committee may decide to carry out this exercise again this year with those members who did not respond on the last occasion. I strongly urge those members to co-operate if there is another request made.

Which brings me to the question of membership generally and, even though 30 members did not renew their membership subscriptions for 1991 and 6 members entered the 'pearly gates' leaving no spouses to carry on in their place, we enrolled 96 new members. This meant an overall increase in membership of 60 for the year, a very good result with numbers getting very close to the 900 mark. I am also pleased to report that we have now completed both a new manual and also an electronic record of membership.

Members are reminded that the Association, though formed in the first place to look after the interests of retired government officers, has developed into what I believe to be the largest active group of men and women who share the common experience of having lived and worked in PNG. I sincerely wish that members would inform their friends, who are not members, but are ex-residents of PNG or who still live and/or work there, that now the only qualification for membership is that they still live or have lived for a period in PNG, because we continue to receive many queries concerning the qualifications for membership.

The Association, I am pleased to report, is in a strong financial position and although I wish to make some comment with respect to that, the Financial Statement and Balance Sheet, I will defer comment until after the Treasurer has presented her report.

I also have a few observations to make concerning our Constitution but I will leave these until we deal with this item on the Agenda later in the meeting.

Before closing, there are a few other matters which I should touch on

briefly, so please bear with me a little longer.

A great amount of time and effort has been expended by Mr. Bob Pulsford and Mr. David Marsh in endeavouring to compile an accurate synopsis of events which transpired during and after the Mt. Lamington eruption. In answer to a request by us in the Newsletter for information, there was a generous response from members and others. Bob and Dave have spent many hours sifting through the information supplied, checking with The Mitchell, The Sydney Law, The National Library and other repositories of information and records concerning the eruption. Nevertheless, there still remains some conflicting information concerning the events which took place on that fateful occasion and I regret that we do not possess the resources to pursue the matter further. All the material which has been collected will be kept by the Association should an appropriate researcher in the future wish to make use of it.

There are two other matters which I will mention very briefly. Firstly, the replacement of the plaque which was erected in memory of Captain Sidney W. Peebles, Robert Kennedy Earl and Keith Royal Kear who were killed in an air crash at Yarramanda Airstrip in the PNG Highlands; and secondly, the winding up of The New Guinea Womens' Association and the very significant contribution made by that Association towards a Community Centre named "Haus Niugini" at the RSL Park at Frankston in Victoria. Full details concerning these matters will be included in either the next September or December issue of the Newsletter.

I apologise for the length of this report but, as it is my last Annual Report to you as President, I felt that there were a number of matters I should touch upon. With the approval of the meeting, I would like to continue (continued page 4)

as President for a further three months before handing over to my successor, whom I will propose and recommend for your consideration later during the  $\ensuremath{\mathsf{I}}$ 

election of office bearers and Committee.

Reiterating what I have said on previous occasions, I have indeed been honoured to be your President for the past six years and I again thank you all for giving me the opportunity to serve you in this capacity. My very special thanks to my wife Candy who has always been most helpful and supportive and extremely tolerant of the time I have spent in carrying out the duties of President and Editor of *Una Voce*. As you are aware, Candy has herself also contributed greatly in the past to the operation and development of the Association and its activities, particularly in the Association's Caring role.

The past year has, unfortunately, been a very trying one for both of us, culminating in the loss of our eldest son, Wayne, in February after a long and debilitating illness. We now feel that the time has come for us to try and

relax and take things easy for awhile.

With respect to *Una Voce*, it is hoped that, with a much greater involvement by other members of the Editorial Sub-Committee and, if it is your wish that I do so, I will be able to continue as Editor for a time. It is absolutely essential, however, that a younger and more active member be found to take over this task in the not too distant future.

Thank you all for your patience and the interest you have displayed

during the delivery of my report." D. J. Parrish, President.

The Treasurer, Mrs. Holmes, presented the Balance Sheet and Statement of Income and Expenditure for the year ended 31 December 1991. She referred to the Explanatory Notes and explained in more detail some of the issues involved.

The President said that even though the Balance Sheet showed a loss of \$656.51 for the year, this was brought about, as explained by the Treasurer, in making provision for income tax payable for 1991 as well as having included the income tax for last year (1990) as an expenditure for 1991, but, in addition, provision has also been made for depreciation which in previous years has not been taken into account. The operations for the year in effect did not operate at a loss.

The financial statements were then accepted on the motion proposed by

Mr. Johnston, seconded by Mr. Sinclair. Carried.

Mrs Holmes asked that it be recorded that Mr Johnston had been of great assistance to her in the process of taking over the duties of Treasurer from him.

The Secretary, Mr Nitsche, advised that all correspondence had been of a routine nature and had been dealt with in the normal way. It was available

for perusal if required.

Prior to the Election of Office Bearers, Mr West proposed that, as no new nominations had been received, all positions currently held be confirmed. The Meeting agreed. Mr Parrish then read out the names of all persons occupying the executive positions and those of the Committee, and explained that, with respect to the position of President, Mr. Harry West had been nominated, but would not be available to occupy the position until 1 August 1992. Mr. Parrish said he was prepared to carry on until then if this arrangement was acceptable to the meeting.

On the motion of Mr. Pulsford, seconded by Mrs. Holmes, that the current Office Bearers and Committee be re-elected and Mr Parrish continue to act as President until Mr. West is free to take over 1 August of this year. Carried.

#### EXPLANATORY NOTES ON ACCOUNTS FOR YEAR ENDED 31 DECEMBER, 1991

- The management of Hambros Cash Management Trust was taken over by Colonial Mutual Funds Ltd at the end of 1990 and the investment will be shown as Colonial Mutual Funds in future.
- (2) Depreciation: I believe this is the first year there has been provision for depreciation of non-current assets, e.g. computers and printer. The older computer and printer has been devalued by 3 years accumulated depreciation at 36% per annum and is nearing the end of its useful life. The second computer, purchased in 1990, allowed 1 year depreciation at 36%.
- (3) Our membership records have now been reorganised to enable a more accurate calculation of subscriptions paid in advance for the current year and for future years. This has been adjusted via transfers from accumulated funds.

The amount of subscriptions in advance was calculated from membership records which show the years to which subscriptions have been paid in advance by various members, given the value for each year at the present rate of \$8.

- (4) Income tax is payable on our investment income after deducting minor related expenses. The operating results for this year are distorted by the inclusion of the income tax paid in respect of the previous year and our estimated liability for this year.
- (5) Part of accumulated funds will be utilised in the near future to replace existing non-current assets which can no longer be economically maintained. It is essential that a reasonable balance be retained in our accumulated funds to provide for unforeseen contingencies.

#### NEWS FROM CORRESPONDENTS (continued)

Ian was then sent to the Trobriands for further hazardous rescue work. After one operation he was awarded an immediate Distinguished Flying Cross. He was keen to return to Maprik so left our ship at Madang and flew to Wewak on Air Niugini. Through Ag. Department contacts Doug Franklin was able to get Ian to Maprik where a kivung had been organised by Robert Rop, ex PATI 1975. Not only did the lapuns remember Ian from before the war but they reminded him that he used to go on patrol on a horse called "Jack"! — which Ian told me he had forgotten. A wonderful story and a hero in anyone's books. After leaving PNG Ian worked in Queensland DPI for many years and was an External Examiner for Gatton. His wife Bunny who he married at Wewak in 1940 died in July 1991. Ian is 77 years, very well and lives in Brisbane.

<u>Dot Loutit</u> Worked in the Health Department Port Moresby as a Dental Nurse in 1946. Later she transferred to private enterprise and worked in Ian Chester and Donald Clouston's Dental Practice Port Moresby until her return to Australia in 1967. Dot is fine and lives in Brisbane.

Peter Wenke In PNG from 1950 to 55 as a Patrol Officer. He was posted at Ambunti and Lae and worked under Brian Heagney and (Sir) Horrie Niall. After his return to Australia he took up a flying career and was a pilot with TAA for 33 years. He was retired when he turned 60 and now lives in Melbourne.

Carl Mayoh Worked as an Assistant Secretary at Government House during the time of J.K. Murray. Then as OIC of Housing Department Administration Messes. He joined DASF and was posted to the Mekeo area. Later he applied for and was successful in winning a Soldier Settler block at Sangara, Popondetta, in 1962. Carl was one of the few who made a success of his cocoa plantation despite the problems of pantorhytes, dieback, caterpillars etc. He left his plantation Bisi in 1962 when it was resumed for the Higaturu Oil Palm Project. He told a story that when on the way to Sogeri in 1960 he was watching the petrol gauge and could see they were going to run out of petrol. On asking the driver if he was aware of this he replied 'Yessir - "E" means Enough and "F" means Finish.'

Graham and Florence Jamieson Graham joined DASF in 1959 after completing a Territories Scholarship to study Agricultural Science at Queensland University. He was posted to Finschhafen and then to Pindiu. In 1960 he went to Keravat where he remained as an Agronomist until 1965. After Long Service leave he joined Queensland DPI where he remained for the rest of his career. Graham was born at Wau and while the ship was at Lae was one of several who joined a charter aircraft organised by an ex U.S. Air Force pilot to fly to Wau. Graham was a boy in Rabaul in 1937 during the volcanic eruption. He said he can remember the harbour a mass of floating coconuts and pumice. He and Florence live in Brisbane.

# ARCHIVING P.N.G. MEMORABILIA

We are all getting older and as we do we progressively are less able to store and thus preserve our valuable documents generated or collected during our life in PNG. Peter Cahill (ex-PNG Department of the Administrator) wrote to *Una Voce* in response to Bob Bunting's words in the March 1992 issue (Page 10): ("It may in fact be pertinent to establish a repository library for literary works on PNG and to call on members to donate books and unpublished articles and stories to be kept for posterity...") and has offered to manage such a project for *Una Voce*.

Peter's credentials are ideal having two post-graduate degrees based on documentary research on PNG material: ("The Chinese in Rabaul 1885-1960", for an M.A. and "The Plantation Industry on the Gazelle Peninsular 1914-1918", for a Ph.D) and has post-graduate qualifications in librarianship. He is also younger than most of us and is only now considering retirement from his present position, so has plenty of energy to apply to this task. He has asked the executive to get legal advice to cover copyright of the material and to prepare a donation form to ensure that the intention of the donors is protected. He continues; "Donations should be made to the Executive of \*Una Voce\*\*) which could pass items to me for inclusion in the database. Once this has been done the material should then pass to an academic/research library for safe keeping. The Australian National Library in Canberra would be the logical choice, if donors agreed.

The database would include anything written, e.g. diaries, letters, short stories, poems, patrol reports, correspondence to and from Administration and Commonwealth departments (relative to PNG). Photographs (please, with identification on the back!), maps, charts, sketches would be very valuable also although I'm not quite sure at this stage how these would be copied. Even if people thought the items may not be particularly interesting they could send them in for examination. We would have to be careful that material containing anything offensive/libellous/defamatory to living persons (I have seen a collection in Brisbane which fits quite happily into all three categories and is fascinating reading!) had some sort of access/time restriction imposed before it became freely available for viewing. Perhaps a clause could be included on the donation form which gave the executive discretion to dispose of any unsuitable material as it saw fit if the donor didn't want it returned."

A REQUEST: Quite apart from the above. Peter is currently writing about life in Rabaul in the 1920-1940 period. He would very much appreciate the assistance of any person who could supply him with some information. Can you describe the furniture, ornaments, curtains, colour schemes etc. as used in homes as accurately as possible. "Was the furniture Manilla cane? Were camphorwood chests all the rage along with the Chinese carved furniture popular in Rabaul in the 50's and 60's? Was there much, if any, native furnishings (mats, carvings, Trobriand Isand style occasional tables) or were these not considered appropriate? I'd be grateful if readers could fill me in on the odd details as it is embarrassing to write something that proves to be incorrect."

## PNG NEWS

Pam and Doug Franklin visited Honiara, Madang, Lae, Port Moresby and Townsville in May 92 on the cruise liner "Belorussiya". Here are some are some of their impressions:

Madang: As beautiful as ever. The town and countryside absolutely clean due to an on the spot fine system introduced to curb litterbugs. Behind the Coastwatcher's Memorial is a fine new Spanish style two storey hotel looking out to sea. Peter Barter's Madang Resort Hotel now includes several individual waterfront chalets. Peter, incidentally, is standing for the Madang Open seat in the forthcoming national elections due in June '92. He hopes to lend more weight to the tourism industry.

We did a full day tour visiting villages in the hills including Baitabag where a sing sing was in progress. It included our favourite bamboo band. The north coast road to the new Malolo Lodge, opposite Karkar Island, and formerly Plantation Hotel, was as good as any interstate highway in Australia.

Lae: Philip Franklin met us on the wharf. His charming wife Louise put frangipani leis round our necks — we knew we were back in Melanesia. The drive along Milford Haven Rd to town was much the same. The buildings had all had a coat of paint for the recent South Pacific Games and visit by Prince Andrew. The former town airport is still awaiting redevelopment and there were signs that the city roads were short on funding. There is a debate as to who is responsible for Lae roads — Central Government, Provincial Government or the Lae City Authority. This is understandable, with huge semi trailers from the Highlands on the roads. We were told the population of Lae is 80,000 and growing. We visited the War Cemetery and Botanical Gardens, both well kept. The golf course looked excellent.

<u>Samarai</u>: The ship passed through the China Strait and close to Samarai. It looked peaceful and quiet just after lunch. Belorussiya gave a couple of welcome toots. We could see the copra sheds and residential houses but someone said that most of the latter had been vandalised and not many people lived on Samarai now. There didn't appear to be any sign of life. The islands and beaches were beautiful.

<u>Port Moresby</u>: The first impression approaching Moresby from the sea is countless new buildings. High rises in downtown Moresby and blocks of flats and units on the hills. We were met by Max Day, former kiap, D.O.Lands and now Lands Consultant, who took us for a comprehensive city tour. His wife Judith owns a law practice in town.

The Papua Hotel (top pub) site is bare having been cleared by a fire. A huge new building is on the Bottom Pub site. Burns Philp have just put their town store for sale at K4.2 million. Old residents will remember the squeaking punkah in the store before the days of air conditioning. Ela Beach is undergoing redevelopment — the RSL is gone, also in a fire. The drive to Waigani on a four lane highway was busy as ever. The Islander Hotel has a four storey extension. The "pineapple building", once the pride of Government architecture at Waigani has again been condemned as a fire hazard and there are rumours that it may be demolished. The once shining fibre glass window frames are now stained by age and mould. Several large buildings were under construction or newly completed at Waigani.

Gordon Market, which we visited, has been rebuilt. It is clean and excellent. Coming back to town via Boroko we saw the remains of our house at 47 Bisini Parade. It had been consumed by a fire recently. Pam and I were (continued page \*12\*)

there for seven years and Peter Ramm before that. We felt sad – it was a good house.

Coming to Konedobu we learned that the proposed tunnel through Burns Peak to connect Spring Garden Rd Konedobu to Hohola and Waigani will now be a cutting. The excavation will go towards filling the harbour to extend the container terminal. RPYC yacht club is to move to a site towards Hanuabada, near the Hubert Murray Stadium. Ranuguri Hostel at Konedobu is no more. Some of us may give a cheer. It was not clear what had happened to it but rascals had helped to wreck the buildings. A concrete pad is all that is left.

In the late afternoon we repaired to Travelodge for a thirst quencher. There we met Fred Haynes, former kiap and now with B.P. (PNG) and Chris

Warrilow ex ADC Kagua, Tari etc. Chris is with Minerals and Energy.

We said goodbye to three most memorable days in PNG. It is a mistake to believe that the country is not fairly and squarely on the right track of progress and development. The improvements in the eight years since we went finish are positive and exciting. A great credit to Papua New Guineans. Sure there are problems but they have to be taken in the right context and not the negative wrong one as we are led to believe most of the time. A last note—when we changed our money for Kina we were given a fine new K50 bank note on which was Sir Michael Somare's portrait. We were told locals call the note "Fifty Michaels".

<u>Honiara</u>: During the day visit Doug found seven of his Popondetta Agricultural College graduates waiting for him on the wharf. It was a great reunion after 17 years. BSIP used to send their Ag. students to PNG for training.

With deep regret we record the passing of the following members and friends. On behalf of the Association the Committee extends our sincere sympathy to their families.

Mr. Jack Chelmsford REILLY (22 May 92, aged 82 years)

Jack was with the PNG Department of Education and arrived in PNG in June 1950 to be posted to Misima Island, Milne Bay Province. He moved to Dregerhafen, Morobe Province in 1952, then Hagara, National Capital Province for a brief period in 1959, prior to being appointed foundation Headmaster of Port Moresby High School.

In 1964 Jack returned to Australia and taught at Nudgee College, Brisbane, before gaining a position under the Colombo Plan in Sabah, Malaysia. After his return to Australia in 1968 he resumed teaching at Woodlawn College, Lismore, a school where he taught before leaving for PNG.

Sir Michael and Lady Veronica Somare paid Jack the honour of attend-

ing the funeral in Lismore.

Jack is survived by his wife Joy, children John, Jim, Peter and

Margaret together with 10 grandchildren and one great grandson.

(I had the honour of knowing Jack when he was at Dregerhafen and found him to be a very fine teacher, excellent school principal, a real gentleman and a sincere friend. It was indeed a privilege for Candy and I to have known Jack and his wife, Joy, and we were saddened when we received word of Jack's passing. Ed.)

Mr. Edgar (Ted) SHELTON (14 May 92, aged 84 years)

Ted commenced his service in May 1946 with the then Provisional Administration as a Pathology and Xray Technician in the Public Health Department in Rabaul following Army Service with a Casualty Clearing Station in Bougainville. He spent many years in Rabaul and time also at the Goroka and Madang hospitals.

He served the Department and the communities, Papua New Guinean, Asean and European alike, faithfully and with distinction until his retirement. His technical ability and advice from wide readings earned him merited appreciation in medical spheres; and his humanity and sound common

sense the fond respect of friends in many walks of life.

Of Ted, Arthur Williams writes: "Ted was Pathology Technician at Nonga Hospital when I first made his acquaintance in the 1960's. His wry sense of humour did much to lessen - for me at least - the normal tensions and frictions among our diverse hospital staff and brightened many a dull day, ..... He and I kept up a sporadic correspondence in which we detailed our woes and troubles in a light vein and commented on many topics with many anecdotes. I shall miss the uplift in spirits that came with that familiar envelope with 'a letter from Ted'."

Mrs. Winifred (Freddie) O'DELL (April 92)

Freddie resided in Port Moresby for many years with her husband John who worked in the PNG Treasury. She was well known for her involvement in productions by the Moresby Musical and Dramatic Society. retirement from PNG, Freddie became Senior English Mistress at Abbotsleigh Girls' School, Wahroonga, Sydney. Both she and John were former POWs in Changi during W.W.II. She is survived by husband, John, who turned 84 on 6 June 92, and son, John.

Mrs. Iris Elizabeth BURCHETT (30 March 92, aged 76 years)

Iris and Ted Burchett were married by ADO Ludlow Downing at Salamaua in 1936. The newly weds flew to Wau the same day and then on to the Upper Watut Goldfields the following day where Ted was running a sawmill. They moved to Wau later to another mill.

Ted served as a Medasst in ANGAU for duration of W.W.II and Iris had to go to Australia to wait out the war. Ted joined the PNG Public Health Department after the war and, whilst they were at Tari, Iris was a Jack of all trades, weather, radio, Post Office and typist for ADO. She received a special mention from the Administrator for her work at radio when a Gibbes Sepik Airways plane crashed at Koroba in August, 1947. Also served as Postmistress at Angoram and later radio operator and Postmistriss at Bereina.

Iris was instrumental in having deep freeze installed at Goroka and Minj to keep perishable food from spoiling if it had to be left overnight due to bad weather. She earned herself quite a reputation for "stirring" on matters concerning the welfare of families when it came to the delivery of essential goods for them. She is survived by her husband Ted.

#### Mrs. Pat EDWARDS (15 April 02)

From 1956 to 1975 Pat was a resident of Port Moresby, where she worked in the Commonwealth Bank, a stockbroker's office and the Taxation Office, and had a large circle of friends. After retiring to the Gold Coast, she was an enthusiastic worker in the community, having been Chairman of the Victoria League, President of the Ionians' 83 Club, President of the Zodiac Luncheon Club and an organiser of the Gold Coast PNG Club's Mahjong meetings. Survived by husband, Alec.

#### Mrs. Margery SMART (March 92)

A funeral service was held for Margery at Port Macquarie on 11 March and Canon Stuart came from Byron Bay to officiate. Margery is survived by husband Percy, one-time Clerk of the House of Assembly, daughter Janet and three grandchildren. She and Percy were among those who endured the terrible experience of the evacuation from Burma following the Japanese invasion in W.W.II.

#### Mr. Angus Roderick SAVAGE (27 March 92, aged 79 years)

Angus joined the PNG Department of Agriculture, Stock and Fisheries 19 December 1947 as a Livestock Officer and left PNG 8 December 1972. He is survived by wife, Dorothy Jeanette. (No further information available.)

#### Mr. Kenneth Clarence FLORENTINE (19 April 92, aged 79 years)

Ken joined the PNG Department of Posts and Telegraphs 8 May 1953 and left 25 September 1970. He is survived by wif, Enid Alice. (No further information was available.)

#### Dr. Anatoly SIKO (April 92, aged 78 years)

Dr. Siko joined the PNG Public Health Department as a District Medical Officer 25 March 1952 and left 2 July 1968. He is survived by his wife, Eileen Elizabeth. (No further information was available)

Mrs. Jean BELL (16 April 92, aged 73 years)

Jean was born in NSW and with husband Eric and a young family - Trevan was then about 9 and Lee about 3, she came to Papua New Guinea in 1951. She found herself managing a store on Kwiara Plantation in Milne Bay Province, and rapidly learned about culture shock and what being busy really meant.

It was here that her love for Papua New Guinea began; the love that

grew into citizenship and into total commitment to the country.

Tragedy touched her in 1960 when husband Eric died. A major strength and support for Jean over this period of loss was friend of the family Brian Bell, and in the fullness of time this friendship blossomed into love, marriage, and the wonderful relationship that has endured until death - and I know will continue to endure in Brian's heart.

In 1977 Brian was appointed Honorary Consul Sweden, and later was appointed to Norway as well. Jean enthusiastically undertook her support role in the diplomatic scene and the wives of many newly appointed diplomates to Papua New Guinea found their settling-in period all the

easier for Jean's readily offered hand of friendship.

As the Norwegian Ambassador remarked just last week while honouring Brian - "Behind every great man there is a great lady" - and Jean was the great lady in Brian's life. Always immensely proud of his successes and always in active support in both his diplomatic and his business life.

Jean was a committed citizen of Papua New Guinea and will be particularly remembered by many for her work for various worthy causes in Papua New Guinea - Red Cross, YWCA, PNG Cancer Society, the recent Jaws of Life Appeal, Friends of the Library and many others over the years. Her energy seemed boundless.

Her capacity to touch people's hearts and to influence them for the

good spread to many people in her adopted country.

In many corners of the world there are people mourning Jean today - a nurse in Peru - an opera star in Melbourne - an artist in Switzerland - a trawler master at sea off Bundaberg - a Chinese doctor from Beijing, (now studying in the USA) identify but a few, of the many who know that they are the better for their lives having been touched by hers.

Jean is survived by her husband Brian and children, Trevan and Lee.

Mrs. Joyce VIDGEN (June 91)

Joyce was the wife of the late Frank Vidgen who was the Director of the Commonwealth Department of Works in Port Moresby at one time. She is survived by daughters, Rosamund and Andrea and a number of grandchildren. (No further information was available.)

Mrs. Maud SINCLAIR (8 March 92)

Maud was the widow of the late Dr. Bruce Sinclair who was a government officer in PNG both pre and post war. Although very advanced in years, Maud was a person of great courage and, even though she fell and fractured four lumbar vertebrae in 1988 and then suffered a stroke which left her without speech and unable to write, her indomitable will and great perseverance enabled her to overcome these afflictions and she learned to read and write again. After receiving a letter from Maud, I wrote and recorded this in the September 1989 issue of the Newsletter and again in the March 1990 issue when I received another letter from her. She was a great lady and is survived by a niece Anne O'Donnell.

Mr. William Andrew (Peter) LALOR (28 March 92, aged 71 years)

After service in the Army, Peter joined the then Provisional Administration of PNG as a Patrol Officer in October 1946 and was posted to the Milne Bay District. He was in Samarai when a power line came down and, whilst he was rescuing another person, stepped on the live wire and had his heel badly burnt. This necessitated long treatment in Melbourne where he also finished a law course and met and married his first wife, Mary.

On return to PNG he joined the Crown Law Department and was assigned to several special projects. In 1960 he was appointed the first Public Solicitor in PNG. Over the years he was very active in the affairs of the Public Service Association, particularly in negotiations with Canberra concerning the status and serving conditions of expatriate officers when self-government was introduced into PNG.

In 1965, whilst on duty as Commissioner for the Girl Guides, Peter's wife, Mary, died in a plane accident. He was greatly affected by this tragedy so in 1967 friends arranged for him to go to Canberra, where he spent six months as Associate Professor of Law at the Australian National University. It was there he met Lynette (Netti) Peterson and they were

married in 1968.

Peter was highly respected by both practising and academic lawyers in Australia as well as PNG. He had a strong social conscience reminiscent of his namesake (possibly forebear) at the Eureka Stockade. Although some individuals or groups may have disagreed with some of his actions as PNG Public Solicitor none ever doubted his intregrity. He felt that conciliation was far more preferable to riots and saw the court system as a way of taking the heat out of some social issues. A tribute to Peter and his work is the Foundation now being set up in his memory.

He is survived by his widow Lynette and his son Michael.

Mr. Leslie Philip BLIAUX (12 May 92, aged 74 years)

During W.W.II Phil joined Royal Corps of Signals and reached the rank of Major. Served in Greece as member of Special Operations Executive. Parachuted twice behind enemy lines to re-organise communications between G.H.Q. Middle East Forces and the Greek Resistance. Served in India and Egypt. Was awarded M.B.E. for gallant and distinguished service in the field.

Phil gained a Batchelor of Science degree in Geo-Physics and, as a Geophysicist, did extensive work with Oil Search and British Petroleum in the 1960s, and was held in high regard by them. Later took up residence at his coffee plantation, 'Koibuga', in the Western Highlands and maintained an agency for technical equipment, though frequently returning to the oil companies for periods of consultancy.

In 1978 he married Joan Tomkin who went to PNG from England.

Ill-health caused him to retire in 1982 to Bagara in Queensland. Well known and respected, his friends in Mount Hagen will hold a ceremony in his honour. He is survived by his wife, Joan, at Bagara.
